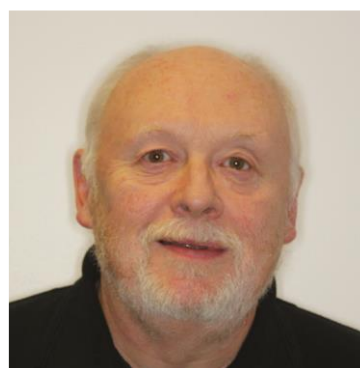
### **Andy Broadbent**
